

J-1 Exchange Visitor Medical Insurance Requirements

To maintain your J-1 status you must obtain and maintain health insurance that meets the minimum requirements as defined by the US Department of State which governs the Exchange Visitor program. "At a minimum, insurance shall cover 1) medical benefits of at least \$100,000 per person per accident or illness, 2) repatriation of remains in the amount of \$25,000; and 3) expenses associated with medical evacuation in the amount of \$50,000. A policy secured to fulfill the insurance requirements shall not have a deductible that exceeds \$500 per accident or illness..." Willful failure to comply can result in your termination from the J program. This insurance requirement also applies to J-2 dependents.

Proof of insurance is required for granting immigration benefits. The **Major Medical Insurance Programs** listed below are some of the plans that meet the minimum requirements of the J-1 Exchange Visitor Program. The section entitled **Medical Evacuation** and **Repatriation Plans** lists companies that may be able to supplement insurance policies that do not include these provisions. You must contact these companies directly to inquire about coverage and rates and to apply for insurance. Please bring proof of insurance to the Center for International Education (CIE) immediately upon your arrival.
